### **Motion**

**Proposed No.** 2024-0104.2 **Sponsors** Dunn 1 A MOTION relating to operations of the juvenile secure 2 detention facility at the Judge Patricia H. Clark Children 3 and Family Justice Center, the youth legal system, and 4 other investments that improve the conditions that young 5 people live in. 6 WHEREAS, in 2012, King County voters approved a \$210,000,000 levy to 7 construct a replacement Youth and Family Justice Center, and 8 WHEREAS, in February 2020, King County began operating the Judge Patricia 9 H. Clark Children and Family Justice Center, and 10 WHEREAS, on July 21, 2020, the executive committed to converting the youth 11 detention facility at the Judge Patricia H. Clark Children and Family Justice Center to 12 other uses by 2025, and 13 WHEREAS, between 2021 and 2024, the executive has transmitted four reports to 14 the council on the strategic planning process for the future of secure juvenile detention at 15 the Patricia H. Clark Children and Family Justice Center; 16 NOW, THEREFORE, BE IT MOVED by the Council of King County: 17 It is the intent of the King County council to maintain operations of the secure 18 juvenile detention facility at the Judge Patricia H. Clark Children and Family Justice 19 Center. King County should continue work to improve the youth legal system, including 20 improving conditions and community-based programming at the Patricia H. Clark

Children and Family Justice Center, and invest in programs and facilities that support transformational change rooted in therapeutic, holistic, and restorative justice principles. King County should also expand investments in stable housing, family supports, behavioral health services, mentorship and positive youth development opportunities, conflict mediation and restorative practices, and other trauma-informed strategies that improve the conditions that young people live in. The King County council supports continued expansion of and improvements to community-based programs for youth and families to prevent or reduce crime, recidivism, and victimization and thereby reduce the need for youth to be incarcerated in secure juvenile detention. The King County council supports the executive in continuing to work with stakeholders to explore development of one or more alternatives, that would provide a safe and therapeutic place for youth who

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

# **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

#### Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

#### Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

#### All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

# **How to contact King County-Department of 02:**

### To advise King County-Department of 02 of your new email address

If you created a DocuSign account, you may update it with your new email address through your account preferences.

#### To request paper copies from King County-Department of 02

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

#### To withdraw your consent with King County-Department of 02

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process.
