1                   A MOTION requesting the executive develop a risk  
2                   assessment related to volatility in federal funding.

3                   WHEREAS, local jurisdictions across the country, including King County, face  
4                   uncertainty around federal funding levels, and

5                   WHEREAS, on January 20, 2025, President Trump issued an executive order  
6                   directing that access to federal funding to "sanctuary jurisdictions" be limited to the  
7                   maximum extent possible under law, and

8                   WHEREAS, on January 28, 2025, President Trump issued through various  
9                   executive orders a temporary pause on all activities related to the obligation or  
10                  disbursement of certain federal financial assistance, including research grants, funding for  
11                  electric vehicles, and some clean energy grants, among others, and

12                  WHEREAS, on the evening of January 28, 2025, U.S. District Judge Loren L.  
13                  AliKhan paused the temporary funding freeze, and

14                  WHEREAS, on January 28, 2025, the White House Office of Management and  
15                  Budget issued a memorandum directing federal agencies to temporarily pause all  
16                  activities related to obligation or disbursement of all federal financial assistance, and  
17                  other relevant agency activities that may be implicated by the executive orders, and

18                  WHEREAS, on January 29, 2025, the White House Office of Management and  
19                  Budget rescinded the memorandum, and

20 WHEREAS, on January 29, 2025, White House press secretary Karoline Leavitt  
21 noted that rescission of the memorandum was not a rescission of the federal funding freeze,  
22 and

23 WHEREAS, on January 28, 2025, President Trump's administration announced a  
24 deferred resignation program for federal workers, allowing them to receive full pay and  
25 benefits until September 2025, at which point they would resign their positions, and

26 WHEREAS, King County and its partners rely on federal funding to support  
27 critical investments in human services, healthcare, mobility, community development,  
28 homelessness services, and more, including for the most vulnerable residents in King  
29 County, and

30 WHEREAS, King County council must be proactive in identifying and mitigating  
31 potential risks associated with sudden changes to federal funding commitments;

32 NOW, THEREFORE, BE IT MOVED by the Council of King County:

33 A. The council requests the executive assess the risks to King County and  
34 provide a briefing to the committee of the whole related to anticipated volatility in federal  
35 funding in the near and long term. The risk assessment should evaluate:

36 1. Federally funded grants and programs received or administered by the  
37 county;

38 2. Potential operational and programmatic impacts that could result from a  
39 partial or complete loss of the federal grants and programs;

40 3. Potential ramifications of a diminished federal government workforce due to  
41 attrition and the federal deferred resignation program; and

42           4. A plan for ongoing evaluation and response, as well as communication to the  
43 council and partners, related to threats of losing federal funding and steps being taken to  
44 mitigate those threats.

45           B. The executive should provide a briefing to the committee of the whole by  
46 February 28, 2025, regarding the risk assessment requested by this motion.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

### **All notices and disclosures will be sent to you electronically**

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

### **How to contact King County-Department of 02:**

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

### **To advise King County-Department of 02 of your new email address**

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at [cipriano.dacanay@kingcounty.gov](mailto:cipriano.dacanay@kingcounty.gov) and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

### **To request paper copies from King County-Department of 02**

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to [cipriano.dacanay@kingcounty.gov](mailto:cipriano.dacanay@kingcounty.gov) and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

### **To withdraw your consent with King County-Department of 02**

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to [cipriano.dacanay@kingcounty.gov](mailto:cipriano.dacanay@kingcounty.gov) and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

### **Required hardware and software**

### **Acknowledging your access and consent to receive and sign documents electronically**

To confirm to us that you can access this information electronically, which will be similar to other electronic notices and disclosures that we will provide to you, please confirm that you have read this ERSD, and (i) that you are able to print on paper or electronically save this ERSD for your future reference and access; or (ii) that you are able to email this ERSD to an email address where you will be able to print on paper or save it for your future reference and access. Further, if you consent to receiving notices and disclosures exclusively in electronic format as described herein, then select the check-box next to ‘I agree to use electronic records and signatures’ before clicking ‘CONTINUE’ within the DocuSign system.
