EXTENSION AGREEMENT

AGREEMENT extending November 1, 1967 contract by and between the DEPARTMENT OF HEALTH OF THE STATE OF WASHINGTON, hereinafter referred to as the "Department," and KING COUNTY, hereinafter referred to as the "County," a copy of which is physically attached hereto.

THE PARTIES TO THIS CONTRACT MUTUALLY AGREE AND UNDERSTAND:

- 1. That the November 1, 1967 contract (attached hereto) between the Department and the County is incorporated by reference into this agreement. The provisions, terms and conditions of the November 1, 1967 contract are controlling except where expressly modified by this agreement.
- II. That Paragraph 7 of the November 1, 1967 contract is modified to reflect a six-month extension of services to be provided by the County in exchange for additional compensation paid by the Department, it being understood that the Department shall pay no more than twenty one thousand seven hundred fifty dollars (\$21,750.00) for the six-month period, January 1, 1969 through June 30, 1969. Paragraph 7 as modified reads as follows:
- III That the following paragraph shall be added to the November 1, 1967 contract as Paragraph 8:
- 8. As a recipient of funds from the State of Washington, the County agrees, and execution of this contract shall serve as certification thereof, that all services rendered shall be provided without discrimination on the grounds of race, creed, color, national origin, sex, or age.

CONTRACT

WHEREAS, the Department through the Health Services
Division is legally authorized by Chapter 70.96 RCW to provide financial
assistance and consultative services to assist in the development,
establishment, construction, maintenance and operation of community
public or private nonprofit facilities for the referral, care, custody,
treatment, recovery and rehabilitation of alcoholics; and

WHEREAS, the Department desires to assist the County in the operation of the Cedar Hills Alcoholism Treatment Center located in Maple Valley; and

WHEREAS, there exists a present and continuing need for additional funds to operate the Cedar Hills Alcoholism Treatment Center, specifically to pay salaries and employee benefits and for certain medical services; and

WHEREAS, the Department has the available funds to help satisfy the present and continuing needs of the Cedar Hills Alcoholism Treatment as specified in this contract for the duration of the contract;

NOW THEREFORE, IT IS AGREED THAT:

1. The Department will allocate and pay to the County a monthly sum not to exceed two thousand eight hundred and seventy-five dollars (\$2,875.00) for reimbursement for expenditures toward salaries and employee benefits for one medical corpsman, two lay counselors and one social worker. The employees for whom this sum is

allocated shall be employed by the County at the Cedar Hills Alcoholism Treatment Center.

- 2. The Department will also allocate and pay to the County a monthly sum not to exceed seven hundred and fifty dollars (\$750.00) to assist the Cedar Hills Alcoholism Treatment Center to obtain medical services for its patients under agreement between the Cedar Hills Alcoholism Treatment Center and the Seattle-King County Health Department.
- . 3. The County agrees to use the sums herein allocated to it for the purposes specified in Paragraphs (1) and (2) of this contract.
- 4. The County agrees to submit monthly vouchers for reimbursement to the Department, which shall itemize all expenditures
 made for the purposes specified in this contract. The vouchers shall
 also include information relating to the number of visits by the
 personnel identified in this contract, and the number of patients
 who have visited the facility during the month for which reimbursement
 is requested.
- 5. Either party to this contract may terminate it after giving thirty (30) days written notice to the other party.
- 6. The parties to this contract may, by mutual consent expressed in writing and executed with all formalities by which this contract is executed, alter the terms and conditions contained herein or fully terminate this contract before its termination date.
 - 7. The contract shall terminate on December 31, 1968.
