

ORDINANCE NO. 81

WHEREAS, a special election was held on the 8th day of July, 1969, in a portion of Alderwood and Cherry Valley Precincts, King County, Washington, for the purpose of voting on the proposition of forming a sewer district to be known as Holiday Lake Sewer District and of electing three commissioners for said district in the event of its formation, and

WHEREAS, the Election Board of King County, Washington, has canvassed the returns of said election and have certified to the following results:

WHEREAS, the said Election Board has declared that a majority of the voters voting upon the said proposition have voted in favor of the formation of said District to be known as the Holiday Lake Sewer District, now, therefore,

BE IT ORDAINED, by the King County Council of King County, Washington, that such sewer district has been formed and established to become a municipal corporation of the State of Washington; that its name shall be Holiday Lake Sewer District, and that its boundaries are described as follows:

All of Sections 22 and 27, Township 26 North, Range 6 East of W.M. in King County, Washington, TOGETHER with that portion of Section 21 in said township and range described as follows: Beginning at the northeast corner of said section; thence westerly along the north line of said section to the north quarter corner of said section; thence southerly along the north-and-south centerline of said section to the north line of the south 660.00 feet in width of the NW 1/4 of said section; thence westerly along said north line to the centerline of the Pacific Northwest Pipe Line Corporation's Main Transmission Line right-of-way; thence southerly along said centerline of right-of-way to a point 480.00 feet northerly of the centerline of Siedel Road; thence easterly, parallel with said road centerline, to a point 510.00 feet easterly of the west line of the SE 1/4 of the SW 1/4 of said Section 21; thence southerly, parallel with said west line, a distance of 450.00 feet to the north margin of said Siedel Road; thence easterly along said road margin 390.00 feet; thence northerly, parallel with said west line, to the north line of the SE 1/4 of the SW 1/4 of said Section 21; thence easterly along said north line and along the north line of the south half (S 1/2) of the SE 1/4 of said section to the east line of said section; thence northerly along said east line to the Point of Beginning.
