WHEREAS, the County Executive of King County, Washington, has been advised by the Superior Court that there is a need for additional personnel, it is necessary to request an emergency appropriation under the classifications of Salaries and Wages, Operation and Maintenance, and Capital Outlay, from August 1, 1969 through December 31, 1969, and

WHEREAS, the County Council finds as a fact that an emergency exists and that this Ordinance is necessary for the immediate preservation of the public peace, health, and safety, and for the support of County Government and its existing public institutions, now, therefore,

BE IT ORDAINED that the emergency appropriation be granted and that the Budget of the Superior Court becamended as follows:
