Order of Establishment

In the matter of the establishment of the South 107th Street (Empire Way South  
to 51st Avenue South) Council  
county road the Board finds as follows:

First. That the Motion No. 82 therefore was \* passed on the  
18th day of July Acting Director, Dept. of Public Works  
19 69, and the County Engineer was duly directed to  
examine and if necessary survey the route of said proposed road.

Second. That on the 15th day of July, 19 69, the County  
County Executive  
Acting Director, Dept. of Public Works  
Engineer filed in the office of the Board his report in writing, and at the same time his field notes and  
profiles of the proposed road, and a map, as provided by law, and the 25th day of August,  
19 69, was set as the day for hearing on said report, and notice of such hearing was duly given by  
publishing and posting as provided by law.

Third. That the Board, having considered said report and all evidence relative to the establishment  
of the road, and finding that such proposed road is a public necessity.

COUNCIL

IT IS ORDERED BY THE BOARD, that the South 107th Street (Empire Way

South to 51st Avenue South) Road be established as follows:

Beginning at a point on the centerline of Empire Way South  
in the NW 1/4 of the SE 1/4 of Section 3, Township 23 North, Range  
4 East, W.M., King County, Washington, said point being 678.90  
feet southerly of the east-west centerline of said Section 3,  
thence in an easterly direction, a distance of 2678.74 feet to  
a terminus on the centerline of 51st Avenue South, 44.53 feet  
southerly of the East 1/4 corner of said Section 3, Township 23  
North, Range 4, East, W.M. King County, Washington

2678.74 feet or 0.51 mile

Acting Director, Dept. of Public Works  
and as shown upon the field notes, profile and map of the County Engineer, and that from henceforth  
said road shall be a County Road of 84 feet in width exclusive of slopes for cuts  
and fills, and that the same be opened according to law.
