ordinance no.

AN ORDINANCE transferring monies allocated to various departments and offices in 1969 Final Budgets for automotive fuels, lubricants and parts to Garage Stores.

WHEREAS, as of August 31, 1969, the budgeted appropriations for Garage Stores is deficient by approximately \$5,000; and

WHEREAS, this deficit has resulted because of a reduction in 1969 appropriations from that budgeted for Garage Stores in 1968 without consideration of an increase in the county vehicle inventory and for the inflation of costs for automotive parts, fuels and other supplies; and

WHEREAS, current budget and accounting procedures have also contributed to this deficit in that purchases from Garage Stores for automotive fuels and supplies which are billed to the various county offices and departments are recorded as non-revenue receipt transfers rather than cash reimbursement and credit to the Garage Stores account; and

WHEREAS, this deficit results in a condition that no automotive parts, fuels, and supplies may be requisitioned for general fleet operations for the remainder of the calendar year thereby seriously impairing the provision of essential county services; now, therefore,

BE IT ORDAINED by the Council of King County, Washington, that the unexpended balances as of September 1, 1969, of all monies allocated to various departments and offices of King County in 1969 Final Budgets for automotive fuels, lubricants and parts, as shown below, are hereby transferred to the Garage Stores account within the Current Expense Fund.
