

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof approving a Final Planned Unit Development on certain property thereon at the request of DONALD A. OLSON a/k/a TYEE-LAKE BOREN MOBILE HOME PARK #2, Department of Planning File No. P 69-127.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Donald A. Olson petitioned July 28, 1969 that the planned unit development be approved on property described in Section 3 below, and this application was assigned Department of Planning File No. P 69-127.

SECTION 2. The Department of Planning along with the Zoning and Subdivision Examiner reviewed this matter July 16, 1971.

SECTION 3. The legal description of the property hereby designated is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance. The final planned unit development plot plan is designated Appendix C and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby classify that property described and shown in Section 3, Appendices A, B, and C above, planned unit development and directs that Area Map No. E 28-24-5 be modified to so designate.

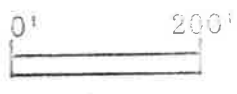

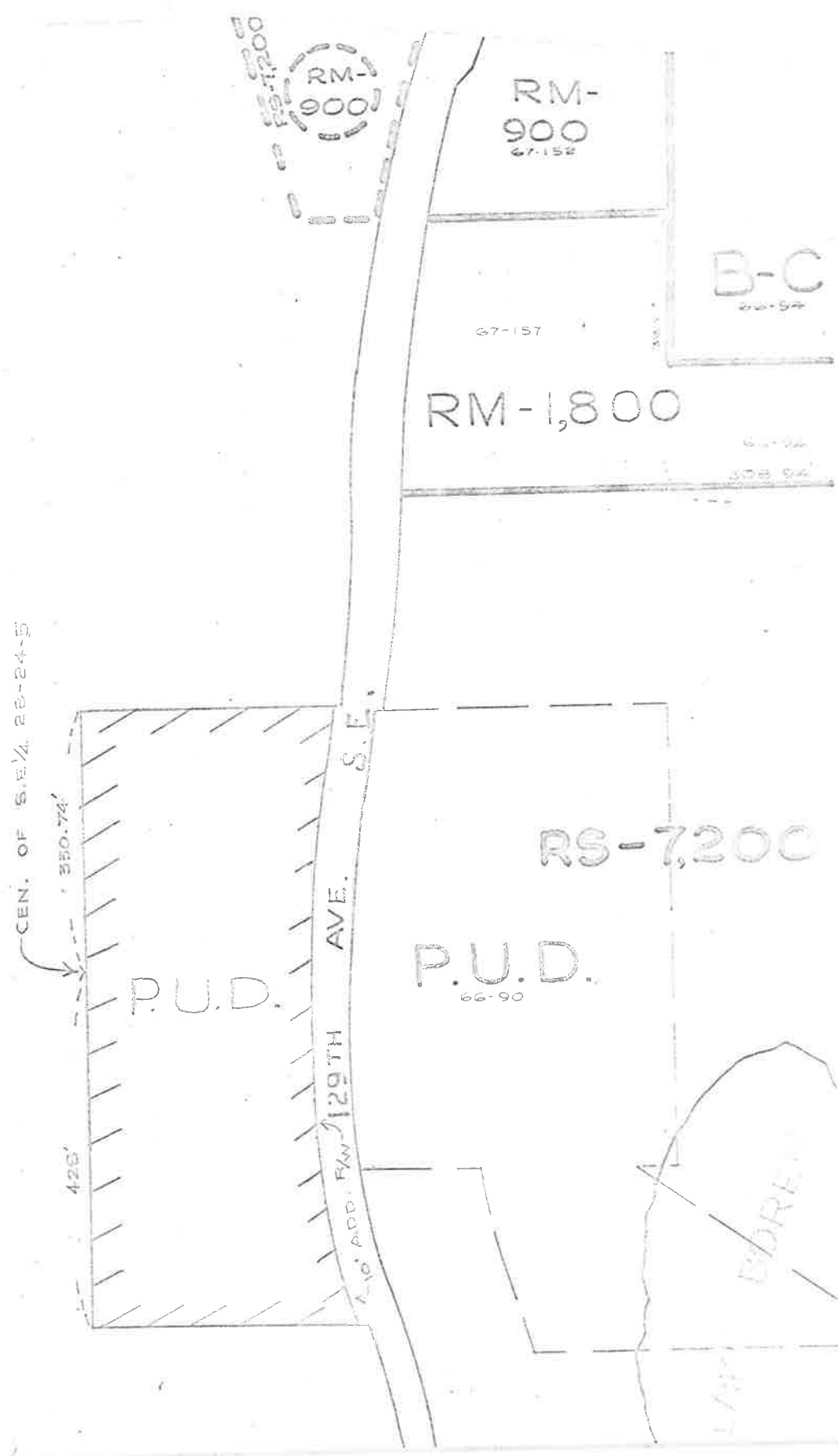
