

1 AN ORDINANCE relating to the application of Rainier
2 Vista Sewer District for a franchise to lay down,
construct, maintain and operate a Sewer Line.

3 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

4 SECTION 1: The franchise extends along, under, and a-
5 cross County roads, and rights of way existing now and as may be
6 constructed in the future within the area described as follows:
7 Beginning at the intersection of the centerline of South 128th
8 Street and the centerline of Block 2, Stimson Park Division No. 1
9 extended South; Thence North along said extension Block 2 and con-
10 tinuing along the centerline of said Block 2 to the center of Lot
11 37, Stimson Park Division No. 1; Thence West along the centerline
12 of said Lot 37, 180.00 feet; Thence South parallel to the center-
13 line of said Block 2, 90.00 feet; Thence West parallel to the South
14 line of Lot 36, Block 2, Stimson Park Division No. 1 and exten-
15 sion thereof to the West margin of 14th Avenue South; Thence North
16 along said West margin to the North line of Lot 24, Block 3, Stim-
17 son Park Division No. 1; Thence West along the North lines of Lots
18 24 and 27 of said Block 3 to the East margin of 12th Avenue South;
19 Thence South along said East margin to a point 118.56 feet South
20 of the South margin of South 128th Street; Thence East parallel to
21 said South margin to the West line of Lot 10, Nestle Nook Park;
22 Thence South along said West line 15.72 feet; Thence East parallel
23 to the South margin of South 128th Street to the centerline of 15th
24 Avenue South; Thence Northeasterly along the centerline of 15th
25 Avenue South to its intersection with the centerline of South
26 128th Street; Thence West along the centerline of South 128th to
27 the point of beginning.

28 SECTION 2: King County Ordinance No. 00468, Amendment
29 Ordinance No. 529, and any other applicable County Ordinance must
30 be complied with by the sewer district desiring said franchise.

31 SECTION 3: The above matter has come regularly for
32 hearing before the King County Council and it appearing that:

- 33 1. The application was properly made.

2. The application was referred to the County Executive for investigation of the feasibility thereof and the checking of the plans and description of the location thereof.

3. The County Executive has made such investigation and has filed with the Council his report and recommendation as follows:

4. Due and legal notice of said application and of this hearing thereon has been given by posting and publication in the manner and as required by law.

SECTION 4: The application of RAINIER VISTA SEWER DISTRICT is approved and the franchise is granted as approved. The same shall be executed on behalf of King County by the County Executive.
