ORDINANCE NO. . 971

AN ORDINANCE relating to the application of Rainier Vista Sewer District for a franchise to lay down, construct, maintain and operate a Sewer Line.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1: The franchise extends along, under, and across County roads, and rights of way existing now and as may be constructed in the future within the area described as follows: Beginning at the intersection of the centerline of South 128th Street and the centerline of Block 2, Stimson Park Division No. 1 extended South; Thence North along said extension Block 2 and continuing along the centerline of said Block 2 to the center of Lot 37, Stimson Park Division No. 1; Thence West along the centerline of said Lot 37, 180.00 feet; Thence South parallel to the centerline of said Block 2, 90.00 feet; Thence West parallel to the Sout line of Lot 36, Block 2, Stimson Park Division No. 1 and extension thereof to the West margin of 14th Avenue South; Thence Nort along said West margin to the North line of Lot 24, Block 3, Stimson Park Division No. 1; Thence West along the North lines of Lots 24 and 27 of said Block 3 to the East margin of 12th Avenue South; Thence South along said East margin to a point 118.56 feet South of the South margin of South 128th Street; Thence East parallel to said South margin to the West line of Lot 10, Nestle Nook Park; Thence South along said West line 15.72 feet; Thence East parallel to the South margin of South 128th Street to the centerline of 15t Avenue South; Thence Northeasterly along the centerline of 15th Avenue South to its intersection with the centerline of South 128th Street; Thence West along the centerline of South 128th to the point of beginning.

SECTION 2: King County Ordinance No. 00468, Amendment Ordinance No. 529, and any other applicable County Ordinance must be complied with by the sewer district desiring said franchise.

SECTION 3: The above matter has come regularly for hearing before the King County Council and it appearing that:
