## SUBSTITUTE ORDINANCE NO. § 972

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of LAURA CORPORATION

Department of Planning File No. 412-71-P

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. LAURA CORPORATION petitioned on March 17, 1971, that the property described in Section 3 below be reclassified from B-N, RM-900 and RM-1800 to B-C and this application was assigned Department of Planning File No. 412-71-P.

SECTION 2. The report and recommendation of the Department of Planning was transmitted to the Zoning and Subdivision Examiner on April 20, 1971, and hearings were held by the Examiner on this matter April 27, 1971, May 4, 1971, and May 11, 1971. The attached report of the Examiner was filed with the Clerk of the King County Council on May 26, 1971.

SECTION 3. The legal description of the property hereby reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above-described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby reclassify that property described and shown in Section 3, Appendices A and B, above to B-C and directs that Area Map No. E 4-21-4 be modified to so designate.

SECTION 5. The King County Council finds that the proposed reclassification, land fill and structure will not be unreasonably incompatible with nor detrimental to affected properties and the general public and that the conditions as set forth by the Council Motion 536 have been fulfilled to the Council's satisfaction.

## LEGAL DESCRIPTION

That portion of the North 480 feet of the West 756 feet $^{\pm}$  of Government Lot 2, Section 4, Township 21 North, Range 4 East, W.M., in King County, Washington, described as follows:
