AN ORDINANCE relating to the application of Northwest Cablevision, Inc. d/b/a Teleprompter of Seattle for an amendment to CATV Franchise No. 547, adding two small areas of land which are contiguous with existing boundaries of Franchise No. 547.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1: All of the land area herein set forth and described including the public roads and rights of way of King County therein lie within King County, Washington, and outside of any incorporated cities or towns; and

SECTION 2: Due and legal notice of a public hearing on application for amendment of franchise has been posted and published in the manner prescribed by law; and said hearing was held on the 13th day of September 1971.

SECTION 3: The King County Council has considered the respective interest proposed and advanced, and is fully advised in the premises hereby finds that the granting of this amendment to Franchise #547 will provide services not heretofore provided and that the described area cannot support more than one Franchise, and is thus in the public interest.

SECTION 4: The amendment is granted to run coextensive with the term of Franchise #547, to expire December 17, 1991.

SECTION 5: The description of the land area in Franchise #547 is amended by adding the land area description contained herein:

AREA A: The South 1/2, Section 3, Township 23 North, Range 4 East, WM.

Also, those portions of Sections 32 and 33, Township 24
North, Range 4 East, and Sections 4, 5, 9 and 16, Township
23 North, Range 4 East, which lie east of the West margin
of Des Moines Way in said Sections 4 and 5, and east of the
West margin of Military Road in said Sections 9 and 16;

EXCEPT any portion of said sections lying within the corporate limits of the City of Seattle as defined July 1,
1971.

1	Containing 900 acres more or less.
2	AREA B: Those portions of Sections 2 and 3, Township 22
3	North, Range 4 East, and Section 35, Township 23 North,
4	Range 4 East, which lie east of the West margin of Orillia
5	Road.
6	EXCEPT any portion of said sections lying within the cor
7	porate limits of the City of Tukwila or the City of Kent
8	as defined July 1, 1971.
9	Containing 600 acres more or less.
10	SECTION 6: In all other respects the terms and conditions
11	of Franchise #547 remain unmodified.
12	SECTION 7: The King County Executive is hereby directed to
13	execute this Amendment to Franchise #547 for and on behalf of King
14	County, Washington.
