

ORDINANCE

NO. 988

AN ORDINANCE relating to amending King County Resolution No. 34569, as requested by the City of Renton, in Resolution No. 1754, revising the list of designated urban arterials within the City of Renton, in accordance with their Six Year Street Program.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Section 1: Resolution No. 34569, Section 3Y, is amended as follows:

1. N. 3rd and N. 4th Street one-way couplet from Logan Avenue North to Sunset Boulevard N.
