AN ORDINANCE relating to the transfer of personal property from King County to Intermediate School District No. 110 and authorizing the County Executive to enter into an agreement with the Intermediate School District No. 110 for services to be provided to them by the County.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Council finds that Chapter 282, Washington Laws as amended by the 1971 first Extraordinary Session provides that all personal property or equity in such property purchased in whole or part with county, state, school district, or federal funds, or any combination thereof, for the use or direct benefit of an office of county superintendent or intermediate district and used and/or in the possession of such office fifty percent or more of the time during the period of January 1, 1969 through July 1, 1969 shall be transferred to and vested in the intermediate school district encompassing the largest percentage of the common school students in the respective county.

SECTION 2. In accordance with its finding in Section 1 King County hereby relinquishes all claim to title and possession of the following personal property to Intermediate School District No. 110:

(a) Items listed in the "Personal Property Physical Inventory, King County Washington: for School District No. 110 as of December 31, 1970 which is by reference made a part hereof.

(b) Vehicles as follows:

SECTION 3. The County Executive shall enter into an agreement with Intermediate School District No. 110 for electronic data processing and other services to be provided by the County
