AN ORDINANCE relating to the vacation of a portion of 129th Ave. S.E. & Portion of S.E. 80th Street (V-1397)

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1: A petition has been filed requesting vacation of the County road hereinafter described.

SECTION 2: The Council on the /3 day of <u>Seconder</u>1971, has declared its intention to vacate and abandon said road.

SECTION 3: Based upon the report of the Department of Public Works, Utilities & Transportation the Council finds that the road to be vacated is useless to the County.

SECTION 4: The Property Management Division has received the sum of Two Thousand Four Hundred and no/100 Dollars (\$2400) for the account of Boise Cascade Building Company as compensation for said vacated road.

SECTION 5: Due notice was given in the manner provided by law and a hearing was held by the King County Council on the day of Secender, 197/.

SECTION 6: The Council has determined to grant said petition. Those lands to be vacated are described as follows: All that portion of 129th Ave. S.E. lying Southerly of the Southwesterly extension of the North line of Lot 3 of Lake Boren Subdivision unrecorded and Northerly of the South line of Sec. 28, Twp. 24 N., R. 5 E., W.M., ALSO, that portion of S.E. 80th Street lying within the NE4 of the NE4 of Section 33, Twp. 24 N., R. 5 E., W.M., Except that portion lying Westerly of the East line of the Mercer Island Pipe Line right of way and Except that portion already vacated; ALSO, the Southerly 30 feet of the NE4 of the NE% of said Section 33, EXCEPT that portion lying Westerly of the East line of the Mercer Island Pipe Line right of way and EXCEPT that portion lying Easterly of the Southeasterly right of way line of 130th Avenue S.E. and EXCEPT any portion of said road already vacated, are hereby abandoned, closed, discontinued and vacated as a public road.
