SUBSTITUTE ORDINANCE NO. * 1106

AN ORDINANCE amending King County Zoning Code Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of LAWRENCE HALE, ET AL

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Lawrence Hale, et al petitioned October 6,1971 that the property described in Section 3 below be reclassified from CG & RM 1800 to CG and this application was assigned Department of Planning File No. 426-71-P (As Amended).

SECTION 2. The report and recommendation of the Department of Planning was transmitted to the Zoning & Subdivision Examiner November 9, 1971, and hearing was held by the Examiner on this matter November 16, 1971. The attached report of the Examiner was filed with the Clerk of the King County Council December 1, 1971.

SECTION 3. The legal description of the property reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map, designated as Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend the King County Zoning Code Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to CG and directs that Area Map No. E 9-22-4 be modified to so designate.
