SUBSTITUTE ORDINANCE  
NO. 1114

AN ORDINANCE amending King County Zoning Code Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of

ETHEL S. NIELSEN, ET AL,  
Department of Planning File No. 127-71-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Ethel S. Nielsen, et al petitioned August 19, 1971 that the property described in Section 3 below be reclassified from RD 3600 to RS 7200 and this application was assigned Department of Planning File No. 127-71-P.

SECTION 2. The report and recommendation of the Department of Planning was transmitted to the Zoning and Subdivision Examiner on September 28, 1971 and hearing was held by the Examiner on this matter October 5, 1971. The attached report of the Examiner was filed with the Clerk of the King County Council October 20, 1971.

SECTION 3. The legal description of the property reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map, designated as Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RS 7200 and directs that Area Map No. W-18-26-4 be modified to so designate.

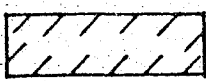

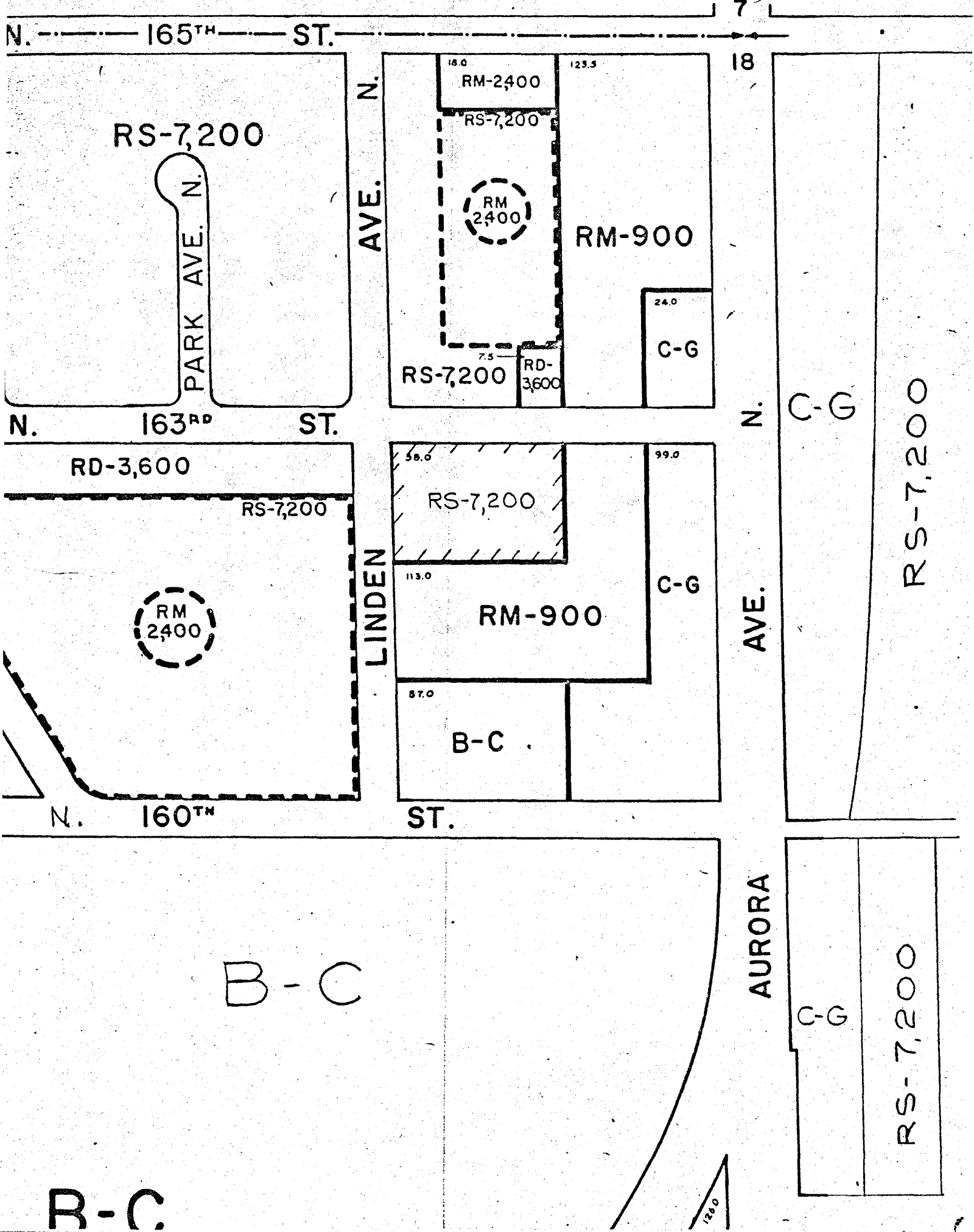
