AN ORDINANCE, authorizing condemnation of property for South 128th Street (8th Avenue South to Military Road) R/W 1973

WHEREAS, it appears that King County is unable to agree with the owners for the purchase of the hereinafter described lands and property, and must resort to condemnation proceedings to acquire the same as provided by law, and

WHEREAS, the King County Council deems it necessary for County purposes and in the best interest of the citizens of King County to acquire the lands and property hereinafter described for road improvement,

NOW THEREFORE,

BE IT ORDAINED by the King County Council that condemnation proceedings are hereby authorized to acquire property and property rights together with the rights to construct and maintain slopes for cuts and fills, and also Temporary Construction Easements on certain abutting property hereinafter described, for the purpose of road improvement.
