3 AN ORDINANCE amending King County Zoning Code Resolution
4 No. 25789, as amended, by amending the Zoning Map thereof
5 adopting a Final Planned Unit Development on certain property
6 thereon at the request of Gai's Seattle French Bakery Co.,
7 Division of Land Use Management File No. 409-73-P

8 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

9 SECTION 1. Gai's Seattle French Bakery Company petitioned on February 16,
10 1973 that the planned unit development be adopted on property described in Section 3
11 below, and this application was assigned Division of Land Use Management File No.
12 409-73-P.

13 SECTION 2. The Division of Land Use Management along with the Zoning and
14 Subdivision Examiner reviewed this matter on July 17, 1973.

15 SECTION 3. The legal description of the property designated is attached as
16 Appendix A and is hereby made a part of this ordinance. The above described
17 property is shown on the attached map which is designated Appendix B and is hereby
18 made a part of this ordinance. The final planned unit development plot plan is
19 designated Appendix C and is hereby made a part of this ordinance.


20 SECTION 4. The King County Council does hereby amend King County Zoning
