

ORDINANCE NO. 1769

1 AN ORDINANCE appropriating E.D.P. new
 2 systems development funds totaling
 3 \$254,487 to various departments,
 4 amending Ordinance No. 1431, Sections 2
 5 and 3, as amended.

6 The King County Data Processing Policy Review Committee has,
 7 during the period commencing January 1, 1973, to May 31, 1973,
 8 approved E.D.P. new systems development activities totaling
 9 \$254,487.00. The funds provided from Special Programs by this
 10 ordinance are to be utilized for these approved systems develop-
 11 ment activities.

12 The appropriation figures in Ordinance No. 1569 for
 13 Assessments and Special Programs were in error. The Assessments
 14 budget was overstated by \$15,156 and the Special Program budget
 15 was understated by \$15,156. The adjustments to these two
 16 accounts in this ordinance reflect correction of these errors as
 17 well as appropriation of new systems development funds.

18 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
