ORDINANCE

AN ORDINANCE amending King County Zoning Code Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of GLEN ACRES, INC.

Department of Planning File No. 417-72-P

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Glen Acres, Inc. petitioned on June 13, 1972, that the property described in Section 3 below be reclassified from RS-7,200 (Potential RD 3,600) to RS-7,200 and this application was assigned Department of Planning File No. 417-72-P.

SECTION 2. The report and recommendation of the Department of Planning was transmitted to the Zoning and Subdivision Examiner on July 18, 1972, and hearing was held by the Examiner on this matter July 25, 1972. The attached report of the Examiner was filed with the Clerk of the King County Council on August 9, 1972.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this Ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this Ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above,

LEGAL DESCRIPTION

That portion of the SE 1/4 of Sec. 5, Twp. 23N., R. 4 E.W.M. in King County Washington described as follows:

Also that portion of said SE 1/4 described as follows: Beginning at the northeast corner of said plat of Beverly Park Div. No. 4; thence S 0°27'30"E 542.75; thence S 89°50'12"E 320.52' to the True Point of Beginning; thence N 25°59'55"E 111.11; thence S 75°48'01"E 226.77'; thence S 41°28'13"E to a point from whence the True Point of Beginning bears N 89°50'12"W; thence N 89°50'12"W to the True Point of Beginning; thence southerly to the northeast corner of New Glen Acres Div. No. 2 (Vol. 2 of Condominiums, pages 53 through 57); thence west along the north line of said plat N 89°50'12"W to a point which is S 25°59'55"W from the True Point of Beginning; thence N 25°59'55"E to the True Point of Beginning.
