ORDINANCE NO. 1812

AN ORDINANCE relating to the annexation of an area known as the Del Mar Annexation Area to Des Moines Sewer District.

WHEREAS, Des Moines Sewer District, King County, has found the petition for annexation of an area known as the Del Mar Annexation area to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for sewer facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as the Del Mar annexation area and described in Section 2 herein is approved.

SECTION 2. The area to be annexed is described as follows: Beginning at the Southwest corner of the East 1/2 of the Southeast 1/4 of Section 21, Township 22 North, Range 4 East, W.M.;

Thence Northerly along the West line of the said East 1/2 to its intersection with a line 900 feet North of and parallel with the South line of the Northwest 1/4 of the said Southeast 1/4;

Thence Westerly along said parallel line to its intersection with the centerline of State Road No. 1 (Seattle-Tacoma Highway);

Thence Northerly along said centerline to its intersection with the South line of the North 1/2 of the North 1/2 of the Northeast 1/4 of said Section 21;

Thence Easterly along said South line and the South line of the North 1/2 of the North 1/2 of the Northwest 1/4 of Section 22, Township 22 North, Range 4 East, W.M., to its intersection with the Westerly margin of Primary State Highway No. 1:

2	Thence Southerly along said Westerly margin to its intersection with the "C" line, as delineated on that certain Washington State Highway Commission right-of-way drawing Primary State Highway No. 1 Pierce County Line to JCT. SSH. No. 5-A, sheet 16 of 20 sheets, bearing date of approval October 28, 1958;
