ORDINANCE NO. 1813

AN ORDINANCE relating to the annexation of an area known as Rancho Vista #4 to Des Moines Sewer District.

WHEREAS, Des Moines Sewer District, King County, has found the petition for annexation of an area known as Rancho Vista #4 to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary
Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for sewer facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as Rancho Vista #4 and described in Section 2 herein is approved.

SECTION 2. The area to be annexed is described as follows:

Beginning at the intersection of the centerline of So. 176th St. (North line of the Northeast 1/4 of Section 34, Township 23 North, Range 4 East, W.M.) with the Northerly extension of the West line of McMillen's 1st Bow Lake Addition according to the plat thereof recorded in Volume 43 of Plats, page 28, records of King County, Washington;

Thence Easterly along said centerline to its intersection with a line which is 198 feet Easterly of and parallel to the Northerly extension of the West line of Block 1, of Holley-Franklin Addition according to plat thereof recorded in Volume 61 of Plats, page 36, records of King County, Washington;

Thence Southerly along said parallel line to its intersection with a line 130 feet Southerly of and parallel to the centerline of So. 176th St.;

Thence Easterly along said parallel line to its intersection with the Northerly extension of the East line of Block 2 of said Holley-Franklin Addition;
