AN ORDINANCE relating to the vacation of a portion of Solomon Korkela (Bunker) Road #1334 V-1412 Petitioned for by: Totem Girl Scout Council BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1: A petition has been filed requesting vacation of the County road hereinafter described.

The Council on the 10 th day of Alexember, 1973. has declared its intention to vacate and abandon said road.

Based upon the reports of the Department of SECTION 3: Planning and Department of Public Works, Utilities & Transportation the Council finds that the road to be vacated would not be in conflict with the principles and purposes of the Comprehensive Plan and the specific plans in the vicinity of the proposed vacation, the Council finds that the road to be vacated is useless to the County.

SECTION 4: As consideration for the subject vacation a 30 foot road deed is being given by the petitioners for an access to the Tolt River Flood Control Project. The description is as follows: The West 30 feet of the East Half of the NW1/4 in Sec. 22, Twp. 25 N., R. 7 E., W.M., lying North of Solomon Korkela Road and South of the Tolt River.

SECTION 5: Due notice was given in the manner provided by law and a hearing was held by the King County Council on the 12 Th day of March , 1973.

SECTION 6: In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of King County to grant said petition.
