WHEREAS, Northeast Lake Washington Sewer District has found the petition for annexation of an area known as Annexation No. 36

SECTION 2. The area known as Annexation No. 36 to be annexed is described as follows:

All that portion of the NE 1/4 of the SW 1/4 of Sec. 7, T. 26 N., R. 5 E., W.M. lying south of the centerline of the channel of the Sammamish River, more particularly described as follows:

Beginning at the Southwest corner of the Northeast 1/4 of the Southwest 1/4 of Section 7, Township 26 North, Range 5 East, Willamette Meridian, said Southwest corner being on the east boundary of the Northeast Lake Washington Sewer District and the true point of beginning;

Thence Northerly along West boundary of the said Northeast 1/4 of the Southwest 1/4 to the centerline of the Sammamish River as it now exists;
