ORDINANCE NO. 1891

AN ORDINANCE transferring the Property Tax Reevaluation Advisor to the office of the Seattle-King County Ombudsman, and amending Ordinance No. 891 as amended and Ordinance No. 1205.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 1205, Section 4(d) and K.C.C.

2.84.040 are hereby amended and renumbered as follows:

Divisions. The department of general services shall include, but not be limited to, the following:

- (a) ADMINISTRATION. The function of this division is to provide supervision, direction and administrative services to the department's divisions;
- (b) INQUEST. The function of this section of the administrative division is to provide administrative support in the handling of inquests:
- (c) BOARD OF APPEALS/EQUALIZATION. The function of the board of appeals/equalization is to provide an avenue whereby aggrieved citizens may seek redress from decisions and assessments of other county agencies, and to equalize the true and fair market value of properties within any given area of the county;
- (((d)--PROPERTY-TAX/EVALUATION-ADVISOR;--The-function-of-this division-is-to-provide-advice-to-any-person-liable-for-payment of-property-taxes-in-the-county;))
- (\underline{d}) ((e)) AUTO LICENSES. The function of this division is to ensure the proper licensing of vehicles as required by law;
- (e) ((f)) MARRIAGE LICENSES. The function of this division is to issue marriage licenses according to law;
- $(\underline{f})((\underline{g}))$ BUSINESS LICENSES. The function of this division is to ensure the proper licensing of businesses as required by law;
- (g) (th) VETERANS' AID AND VETERANS' AID EMPLOYMENT OPPORTUNITIES. The functions of this are:
