AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Kenneth D. Donohue, et. al., Division of Land Use Management File No. 126-73-P.

SECTION 1. Kenneth D. Donohue petitioned on September 7, 1973, that the property described in Section 3 below be reclassified from B-C to C-G, and this application was assigned Division of Land Use Management File No. 126-73-P.
