ORDINANCE NO.

AN ORDINANCE granting Unclassified Use Permit as provided for in King County Zoning Code Resolution No. 25789, as amended, at the request of Puget Sound Power and Light Co., Division of Land Use Management File No. 310-73-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Puget Sound Power and Light Co. petitioned on April 3, 1973, for an unclassified use permit to allow an electrical conversion station (switching station) as described in Section 3 below, and this application was assigned Division of Land Use Management File No. 310-73-P.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on July 31, 1973, and hearing was held by the Examiner on the matter August 7, 1973. The report of the Examiner was filed with the Clerk of the King County Council August 30, 1973, with Motion No. 1296.

SECTION 3. The legal description of the property designated is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map, designated Appendix B and is hereby made a part of this ordinance. The unclassified use permit topography plan is designated Appendix C and is hereby made a part of this ordinance.

SECTION 4. As provided for in King County Zoning Code Resolution No. 25789, as amended, the King County Council does hereby grant the unclassified use permit to allow an electrical conversion station (switching station) described and shown in Section 3, Appendices A, B, and C above, and directs that Area Map No. E 23-22-5 be modified to so designate.

SECTION 5. This permit is granted subject to conditions adopted in Council Motion No. 1296, and said conditions are incorporated herein as though fully set

forth herein. Unless otherwise s	stated in said motion, the Division of Building shall
not issue a grading permit until	determined that all said conditions have been met.
