

ORDINANCE NO. 1951

AN ORDINANCE relating to the annexation of an area known as Crystal Glen to King County Water District No. 58.

WHEREAS, King County Water District #58 has found the petition for annexation of an area known as Crystal Glen to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for water facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 58 of the area known as Crystal Glen and described in Section 2 herein is approved.

SECTION 2. The area known as Crystal Glen to be annexed is described as follows:

Beginning at the intersection of the North line of Section 10, Township 22 North, Range 5 East, W.M., with the East line of the West half of the West half of the West half thereof, also being a point on the existing boundary of Water District No. 58;

Thence South along said East line to the South line of the North quarter of the Southwest quarter of the Northwest quarter of said Section 10;

Thence East along said South line to the East line of the West quarter of said Section 10;

Thence North along said East line to a point lying 860 feet South of the Northwest corner of the Northeast quarter of the Northwest quarter;

Thence East 108.9 feet;

Thence North 200 feet;

Thence East to the Southeast corner of the West half of the Northwest quarter of said Northeast quarter of the Northwest quarter;

1 Thence North along the East line of said West half of
2 Northwest quarter of said Northeast quarter of the
3 Northwest quarter to the South line of the North half
4 of the Northwest quarter of said Northeast quarter of
5 the Northwest quarter;

6 Thence West along said South line of the North half of
7 the Northwest quarter of the Northeast quarter of the
8 Northwest quarter to an inter section with a line paral-
9 lel to and 270 feet East of the West line of said
10 subdivision;

11 Thence North along said parallel line to the North line
12 of said Section 10;

13 Thence West along said North line to the East line of
14 the West half of the West half of the West half of Sec-
15 tion 10, Township 22 North, Range 5 East, W.M. and the
16 Point of Beginning.
