ORDINANCE NO.

2006 74 - 364

WHEREAS, the King County Council on November 30, 1973, by Ordinance No. 1859, did adopt the 1974 Annual Budget for King County, and did provide therein for the Capital Budget and Program, which included a Transportation Program, and

WHEREAS, the King County Transportation Program provides for the county road system development and improvement program coordinating the kind of road with other elements of the larger transportation system, abutting land uses and business, industry, government and residential processes, and

WHEREAS, the Capital Budget and Program provides for the acquisition and construction of 228th N.E. Extension (N. E. 8th - Redmond/Fall City Road), and

WHEREAS, in order to acquire the property and property rights required to lay out and construct 228th N.E. Extension (N.E. 8th - Redmond/Fall City Road), it is necessary for King County to condemn certain lands and property rights and rights in property for road purposes as hereinafter more particularly set forth, and

WHEREAS, the King County Council finds that the public health, safety, necessity and convenience demand that 228th Ave. N.E. Extension (N. E. 8th-Redmond/Fall City Road) be constructed within King County in accordance with the Capital Budget and Program, and that certain properties, property rights and rights in property be condemned, appropriated, taken and damaged for the construction of said road, as provided in this ordinance,

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY: SECTION 1.

The King County Council has deemed it necessary and in the best interest of the citizens of King County that the lands hereinafter described, and other property rights and/or rights in property be condemned, appropriated, taken and damaged for the purpose of constructing 228th N.E. Extension (N. E. 8th - Redmond/Fall City Road), subject to the making or paying of just compensation to the owners thereof in the manner provided by law.

The attorneys for King County are hereby authorized and directed to begin and prosecute the proceedings provided by law to condemn, take and appropriate the land and other property and property rights
