The requirements of RCW 56.24.070 and RCW 36.93.090, 36.93.093 and 36.93.100 for annexation of territory to a sewer district have been fulfilled by Lakehaven Sewer District.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The proposed annexation of territory known as Holiday Park to Lakehaven Sewer District will be conducive to the public health, welfare and convenience and will be of special benefit to the land included within the boundaries of the territory proposed to be annexed.

SECTION 3. The boundaries of the territory to be annexed to Lakehaven Sewer District are hereby described as follows:

Beginning at the Southwest corner of Section 5, Township 21 North, Range 4 East, W.M., King County, Washington;

Thence Northerly along the West line of said Section 5 to the intersection with the centerline of Dash Point Road;

Thence Easterly and Northerly along the centerline of Dash Point Road to the intersection with the East line of the Southwest quarter of the Southwest quarter of said Section 5;

Thence Southerly along said East line to the South line of said Section 5;

Thence Westerly along the South line of Section 5 to the Northeast corner of Lot 7, Plat of Holiday Park No. 2 as recorded in Volume 68 page 75, records of King County, Washington;

32 33 Thence Southerly along the East line and Southerly extension thereof to the centerline of South 304th Place;

Thence Westerly along the centerline of South 304th Place to the intersection with the Northerly extension of the East line of Lot 8 of said plat of Holiday Park No. 2;

Thence Southerly along the East line of said Lot 8 and the Northerly extension thereof to the Southeast corner of said Lot 8;

Thence Westerly along the South line of said Lot 8 to the Northeast corner of Lot 10 of said plat;

Thence Southerly along the East line of said plat of Holiday Park No. 2 and continuing Southerly along the East line of the plat of Holiday Park No. 3 as recorded in Volume 72, page 35, records of King County, Washington to the Southeast corner of Lot 28 of said plat of Holiday Park No. 3;

Thence Southwesterly across South 308th to the Northeast corner of Lot 29 of said plat of Holiday Park No. 3;

Thence Southerly to the Southeast corner of Lot 30 of said plat of Holiday Park No.3;

Thence Easterly along the South line of Lot 20 of the Plat of Emberwood No. 3 as recorded in Volume 73, Page 8, records of King County, Washington to the East line of West half of the Southwest quarter of the Northwest quarter of Section 8, Township 21 North, Range 4 East, W.M., King County, Washington;

Thence Southerly along said East line to the Southeast corner of the West half of the Southwest quarter of the Northwest quarter of said Section 8;

Thence Southerly along the East line of the West half of the Northwest quarter of the Southwest quarter of said Section 8 to the Southeast corner thereof;

Thence Westerly along the South line of the West half of the Northwest quarter of the Southwest quarter of said Section 8 to the West line of said Section 8;

Thence Northerly along the West line of said Section 8 to the Point of Beginning.

SECTION 4. In submitting said proposition to the voters for their approval or rejection, the proposition shall be expressed on the ballot in the following terms:
