ORDINANCE NO. 205

AN ORDINANCE prescribing the form of property tax refund petitions under RCW 84.69.020(9), (10), and (11) and in the case of refunds necessitated by RCW 84.60.050(2); amending Ordinance No. 1809, Section 1.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 1809, section 1, is hereby amended to read as follows:

The King County Comptroller shall make available to taxpayers who are entitled to a tax refund by ((a-final-order-of the-State-Board-of-Tax-Appeals, -as-provided-by)) RCW 84.69.020(9) RCW 84.69.020(10), RCW 84.69.020(11), or RCW 84.60.050(2) a shortened refund application form consistent with the provisions of Chapter 84.69 of the Revised Code of Washington. Such form shall include only such information necessary to establish the validity and finality of the ((astion-taken-by-the-Board-of-Tax Appeals)) taxpayer's claim. When such form, together with the decision of the state or local Board, has been filed with the Clerk of the Council and served on the King County Assessor, the Comptroller shall make the appropriate refund determined by the state or local Board ((of-Tax-Appeals)) together with interest as prescribed by law without Council action. Provided: refunds shall be made under this shortened procedure where the taxpayer fails to make application for refund hereunder within three (3) months of the date of receiving the final decision of the state or local Board ((of-Tax-Appeals)); or where the Assessor has given timely notice of appeal from the decision of the state or local Board ((of-Tax-Appeals)). Provided further:
