ORDINANCE NO.

AN ORDINANCE relating to the annexation of areas known as Parcel 1, 2, 3, 4, 6, 7, and 8, to King County Water District No. 20.

WHEREAS, King County Water District No. 20 has found the petitions for annexation of the areas known as Parcel 1, 2, 3, 4, 6, 7, and 8 to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary
Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for water facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 20 of the areas known as Parcel 1, 2, 3, 4, 6, 7, and 8 and described in Section 2 herein is approved.

SECTION 2. The areas known as Parcel 1, 2, 3, 4, 6, 7, and 8 to be annexed are described as follows:

## Parcel 1

That portion of the southwest quarter of the northwest quarter of section 16, T23N, R4E, W.M., in King County, Washington and of the plat of Park Village, as recorded in volume 38 of Plats, page 9, records of said county, described as follows:

Beginning at the northwest corner of Lot 9, Block 1, said Park Village; thence easterly along the north line of said Lot 9 and its easterly extension to the centerline of 16th Place South; thence northerly along said centerline to the westerly extension of the north line of Lot 3, Block 3, said Park Village; thence easterly along said extension and north line and along the north line of Lots 21 through 36, said Block 3, and its easterly extension, to the centerline of 20th Avenue South; thence northerly along said centerline to the centerline of South 135th Street; thence westerly along said centerline to the centerline of 16th Place South; thence northerly along said centerline to the easterly extension of the north line of Lot 6, aforesaid Block 1; thence westerly along said extension and north line to the west line of said Block 1; thence southerly along said west line to the Point of Beginning.
