ORDINANCE NO.

AN ORDINANCE relating to Code of Ethics for County public officials and employees, amending Ordinance No. 1308, Section 6 and K.C.C. 3.04.050

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 1308, Section 6 and K.C.C. 3.04.050 are hereby amended to read as follows:

DISCLOSURE OF INCOME AND INVESTMENTS. All candidates for county elective office within five days after filing their declaration of candidacy, and all elected officials, paid in whole or in part from county funds, all persons appointed by the county executive, to include board and commission members, all persons appointed by the county administrator which are subject to the approval of the county executive, all employees of the council, and such other public employees as may be determined by the board of ethics, shall file with the board of ethics ((within-ten-days-of-employment-or)) prior to appointment and on or before January 31st of each year a written statement of:

- (1) All sources of income in excess of one thousand five hundred dollars per year; and
- The name of any corporation, firm or enterprise in which he or she has a direct financial interest in excess of one thousand five hundred dollars; provided, that policies of insurance issued to himself or herself, or spouse, accounts in banks, savings and loan associations or credit unions, are not to be considered financial interest; and
- (3) Every office or directorship held by the employee, his or her spouse, or any member of his or her family in any corporation, association, firm or enterprise, both profit and nonprofit, doing business in King County; and
- (4) A list by legal description or popular address of all real property owned in King County by the employee, his or her spouse, or member of the family, including options to buy if the property is valued in excess of one thousand five hundred dollars; and
