ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of M & D Investments, Division of Land Use Mangement File No. 252-74-R

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. M & D Investments petitioned on July 3,1974, that the property described in Section 3 below be reclassified from BC to CG and this application was assigned Division of Land Use Management File No. 252-74-R.

SECTION 2. The report and recommendation of the Division of Land Use Mangement was transmitted to the Zoning and Subdivision Examiner on August 12, 1974, and hearing was held by the Examiner on the matter August 27, 1974. The report of the Examiner was filed with the Clerk of the King County Council on September 11, 1974 with Motion No. 1750.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to C-G and
