9 ORDINANCE NO. 2227

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of
Allen Kleinsasser & Nakata Smith, Division of Land Use
Management. File No. 230-74-R

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Allen Kleinsasser & Nakata Smith petitioned on April 4, 1974, that
16 the property described in Section 3 below be reclassified from SR to RM-900
17 and this application was assigned Division of Land Use Management File No. 230-74-R.

18 SECTION 2. The report and recommendation of the Division of Land Use
19 Management was transmitted to the Zoning and Subdivision Examiner on May 28, 1974,
20 and hearing was held by the Examiner on the matter June 4, 1974. The report of
21 the Examiner was filed with the Clerk of the King County Council on June 19, 1974,
22 with Motion No. 1664.

23 SECTION 3. The legal description of the property to be reclassified is attached
24 as Appendix A and is hereby made a part of this ordinance. The above described
25 property is shown on the attached map which is designated Appendix B and is hereby
26 made a part of this ordinance.

27 SECTION 4. The King County Council does hereby amend King County Zoning
28 Code, Resolution No. 25789, as amended, by reclassifying that property described
29 and shown in Section 3, Appendices A and B above, to RM-900 and directs that


1 Area Map E 31-23-5 be modified to so designate.

4 fully set forth herein.
