AN ORDINANCE relating to the annexation of an area known as Northeast 197th Street to Ronald Sewer District.

WHEREAS, Ronald Sewer District has found the petition for annexation of an area known as Northeast 197th Street to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for sewer facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Ronald Sewer District of the area known as Northeast 197th Street and described in Section 2 herein is approved.

SECTION 2. The area known as Northeast 197th Street to be annexed is described as follows:

That portion of the Northwest 1/4 of Section 3, Township 26 North, Range 4 East, Willamette Meridian in King County, Washington, described as follows:

Beginning at the intersection of the East line of the West 1/2 of the Northwest 1/4 of said Section 3 with the South line of Lot 19 of Block 8, Lake Forest Park First Addition, according to plat thereof recorded in Volume 20 of Plats, Page 82, Records of King County, Washington;

Thence Northerly along said East line to its intersection with the centerline of N.E. 197th Street;

Thence Easterly along said centerline to its intersection with the East line of said Northwest 1/4;

Thence Southerly along said East line to its intersection with the Easterly extension of the North line of Lot 13, Block 9, said plat of Lake Forest Park First Addition:

Thence Westerly along said Easterly extension and along the North line of said Lot 13 to its inters ection with the East lines of Lots 10 and 11, Block 9, said plat of
