BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An additional appropriation of \$15,000 to the Client Services Division of the Department of Rehabilitative Services, Current Expense Fund, from an offsetting reduction in the appropriation to the Supervision and Administrative Support Division of the Department of Rehabilitative Services, Current Expense Fund, is hereby approved and adopted.

SECTION 2. An additional appropriation of \$6,500 to the Judicial Services Division of the Department of Rehabilitative Services, Current Expense Fund, from an offsetting reduction in the appropriation to the Supervision and Administrative Support Division of the Department of Rehabilitative Services, Current Expense Fund, is hereby approved and adopted.

SECTION 3. An amount of \$78,000 from Special Programs, Executive Contingency is hereby appropriated to the Detention Division of the Department of Rehabilitative Services, Current Expense Fund.




