AN ORDINANCE relating to Masseur's, Masseur Trainee's and Massage Parlor Attendant's; amending Resolution 31755, Section 14 and K.C.C. 6.40.160.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Resolution 31755, Section 14 and K.C.C. 6.40.160 are hereby amended as follows:

Duties of the Director. If the director finds that such application is in proper form, and that the references are authentic, he shall:

(a) Refer all applications to the department of public safety with a request to ((phetograph-and)) fingerprint the applicant, and to investigate the statements contained in the application, and to furnish a written report containing the result of his investigation, together with such other information as may aid the director in determining whether such license should be issued;

(b) ((Refer-all applications to the director of the Seattle King County-health department with a request to examine the applicant physically to ascertain if the applicant is free from contagious or infectious disease and be make a written report thereon)) Require to be filed with him a certificate signed by a licensed physician stating that the applicant has been examined and is free from contagious or infectious disease. The scope of the examination and the certificate form shall be prescribed by the Seattle-King County health department;

(c) Refer all original applications for masseur's license to the examining board created by Section 6.40.170 herein;

Provided, however, that all applications for renewal of masseur's license by applicants who have been previously examined and found qualified by the examining board need not be submitted to the examining board; and

Provided, further, that the requirements of Section 6.40.180 shall apply to all renewal applications for masseur's licenses by applicants previously licensed under Section 6.40.120 except that such applicants need not comply with Section 6.40.180 for a period of six months after the date that testing is first made available.
