ORDINANCE NO.

AN ORDINANCE relating to the merging of King County Water District No. 35 with King County Water District No. 38.

WHEREAS, the boards of water commissioners of both King County Water District No. 35 and King County Water District No. 38 have determined by resolution that the merger shall be conducive to the public health, welfare and convenience and to be of special benefit to the lands of both districts; and

WHEREAS, the King County Council finds said merger is in the public interest and is not inconsistent with the county plan for water facilities, and of benefit to the land included within the boundaries of the territory to be merged.

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The merger of King County Water Districts No. 35 and No. 38 described in Section 2 herein is approved subject to results of a special election to be held within the boundaries of the territory proposed to be merged.

SECTION 2. King County Water Districts No. 35 and No. 38 to be merged are described as follows: (legal description attached) .

WATER DISTRICT NO. 38

Created August 4, 1930 Resolution No. 3748

Commencing at the Southeast corner of lot 7, block 4, of the Second Addition to Adams Home Tracts, as recorded on page 90 of volume 12 of plats, records of the Auditor of King County, Washington; running thence North approximately 2350 feet to an intersection with the North line of Section 22, Township 23 North, Kange 4 E.W.M.; thence West along said Section line approximately 70 feet; thence North approximately 800 feet; thence West approximately 850 feet; to an intersection with the centerline of the Southeast Quarter of Section 15, Township 23 North, Range 4 E.W.M.; thence North along said centerline approximately 1250 feet; thence East approximately 100 feet to the centerline of State Aid Road No. 1; thence Northerly along the centerline of State Aid Road No. 1 approximately 650 feet to an intersection with the East and West centerline of Section 15, Township 23 North, Range 4 E.W.M.; thence West along said centerline of said section 15 approximately 2800 feet to an intersection with the centerline of E. L. Fraeger Road Number 76 (Hilitary road); thence southerly along the centerline of G.
