AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Everett L. Woods, Division of Land Use Management File No. 270-74-R

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Everett L. Woods petitioned on October 16, 1974, that the property described in Section 3 below be reclassified from B-C to C-G and this application was assigned Division of Land Use Management File No. 270-74-R.

The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on December 3, 1974, and hearing was held by the Examiner on the matter December 10, 1974. The report of the Examiner was filed with the Clerk of the King County Council on December 26, 1974 and the Council approved the reclassification by Motion No. 1853 on January 13, 1975.
