ORDINANCE NO.

AN ORDINANCE making an appropriation of \$6,700 from the Executive Contingency Reserve to Consulting Services in Special Programs as King County's share of local matching monies to Urban Mass Transportation Administration, Coordinated Support Program, funds for a Study to analyze and evaluate the mass transit substitution alternatives for the I-90 Corridor, and amending Ordinance No. 2230, Section 49 as amended.

WHEREAS, provisions of the 1973 Highway Act, as amended, allow for transit substitution in lieu of an Interstate highway facility; and

WHEREAS, the Puget Sound Governmental Conference's I-90 Committee has developed a work program (to analyze and evaluate the fixed facility mass transit substitution alternatives for I-90) for recommendation to the Governor's Committee on I-90; and

WHEREAS, the Governor's Committee on I-90 has approved the work program to analyze and evaluate the mass transit alternative substitution for the I-90 Corridor; and

WHEREAS, King County is a participating member on both the Governor's Committee and the Puget Sound Governmental Conference's I-90 Committee.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An appropriation in the amount of \$6,700 to Consulting Services from the Executive Contingency Reserve in Special Programs is hereby approved and adopted for a Study to analyze and evaluate the fixed facility mass transit substitution alternatives for I-90.

SECTION 2. Ordinance No. 2230, Section 49, as amended, is hereby amended to read as follows:
