2 AN ORDINANCE making an appropriation of \$6,700 from the  
3 Executive Contingency Reserve to Consulting Services in  
4 Special Programs as King County's share of local matching  
5 monies to Urban Mass Transportation Administration,  
6 Coordinated Support Program, funds for a Study to analyze  
7 and evaluate the mass transit substitution alternatives for  
8 the I-90 Corridor, and amending Ordinance No. 2230,  
9 Section 49 as amended.

10 WHEREAS, provisions of the 1973 Highway Act, as amended, allow  
11 for transit substitution in lieu of an Interstate highway facility; and

12 WHEREAS, the Puget Sound Governmental Conference's I-90 Committee  
13 has developed a work program (to analyze and evaluate the fixed facility  
14 mass transit substitution alternatives for I-90) for recommendation to  
15 the Governor's Committee on I-90; and

16 WHEREAS, the Governor's Committee on I-90 has approved the work  
17 program to analyze and evaluate the mass transit alternative substitution  
18 for the I-90 Corridor; and

19 WHEREAS, King County is a participating member on both the Governor's  
20 Committee and the Puget Sound Governmental Conference's I-90 Committee.

21 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

22 SECTION 1. An appropriation in the amount of \$6,700 to Consulting  
23 Services from the Executive Contingency Reserve in Special Programs is  
24 hereby approved and adopted for a Study to analyze and evaluate the fixed  
25 facility mass transit substitution alternatives for I-90.

26 SECTION 2. Ordinance No. 2230, Section 49, as amended, is hereby  
27 amended to read as follows:

28 From the Current Expense Fund there is hereby appropriated to:

29 Special Programs \$5,980,111

30 PROVIDED THAT:

- 31 1) The Executive Contingency of ((\$202,287)) \$195,587  
32 shall not be expended unless the County Executive  
33 certifies in writing that funds are available and  
requests that the County Council adopt an additional  
appropriation ordinance; Upon adoption of the ordinance  
and signing by the Executive, funds may be expended for  
the purpose specified;
