ORDINANCE NO. 2373

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Harry A. Abel, Division of Land Use Management File No. 208-75-R

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Harry A. Abel petitioned on November 27, 1974, that the property described in Section 3 below be reclassified from SE to G and this application was assigned Division of Land Use Management File No. 208-75-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on January 21, 1975, and hearing was held by the Examiner on the matter January 28, 1975. The report of the Examiner was filed with the Clerk of the King County Council on February 13, 1975, and the Council approved the reclassification by Motion No. 1897 on March 3, 1975.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.





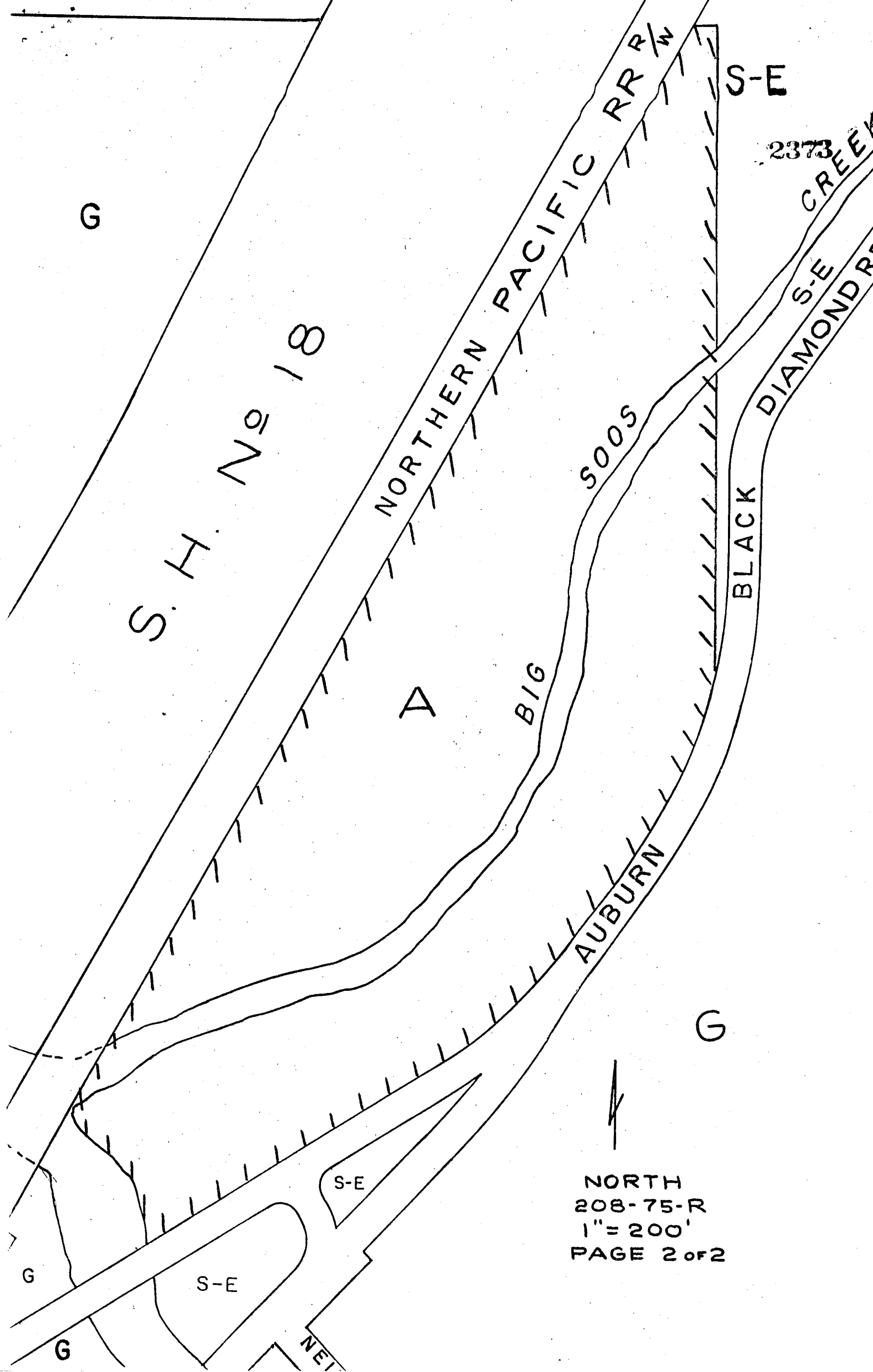
