AN ORDINANCE appropriating \$234,536 to the Public Service Employment Program (CETA Title II) and amending Ordinance No. 2230 as amended.

SECTION 1. An appropriation of \$234,536 is hereby approved and adopted to the Public Service Employment Program (CETA Title II) from unappropriated year-end cash balance for the period January 1, 1975 through June 30, 1975.

SECTION 2. Ordinance No. 2230, Section 61, as amended, is hereby amended to read as follows: From the Public Service Employment Fund (CETA Title II) there is hereby appropriated:

((\$3,580,643)) \$3,815,179

PROVIDED THAT:

- Position 0605-0229 in the Administrative Services program element (5-01-02) of Public Works - Roads shall be funded insofar as possible from CETA;
- 2) For-the-position-of-Executive-Secretary-to-the Arts-Commission-there-is-hereby-allocated-from-CETA funds;-in-addition-to-employment-benefits;-the amount-of-\$\phi\leftarrow\theta\rightarrow\t
- 3) For two positions for Office Assistants I or II in Judicial Administration there is hereby allocated \$17,500 plus benefits from CETA funds;
- 4) New-positions-for-four-stenographers-(including three-CBTA)-and-one-Probation-Officer-IV-for-the Juvenile-Court-shall-not-be-filled-until-the position-of-Director-of-Court-Service-is-filled?
- 5) The-appropriation-to-support-the-Assessment-and Adjudication-Division-of-the-duvenile-Court-shall not-exceed-\$7227387-and-shall-not-be-supplemented from-any-other-sources7-including-CETA7
- 6) The-appropriation-to-the-Social-Bevelopment-element of-the-duvenile-Court-shall-not-exceed-\$63,426-and-shall not-be-supplemented-from-any-other-sources,-including-CHTA,

1 2 3	7) For ((one-planner)), two legislative administrative assistants ((7-one-office-aid7)) and ((two)) three secretaries in the Council Administrator's Office allocations are hereby made from CETA funds;
4 5	8) Continuation of the funding of the seven CETA Maintenance positions in Parks (4 Park Caretakers, 3 Utilitymen) beyond June 30, 1975, shall be conditional on the justification for their need, supported by the developed work standards;
6 7 8	9) For Exploring Aides for the Explorer Division of the Chief Seattle Council of the Boy Scouts of America there is hereby allocated from CETA Funds \$11,520.
9	The County Council intends that:
10	1) New positions for four stenographers (including
11	three CETA) and one Probation Officer IV position for the Juvenile Court should not be filled until the position of Director of Court Service is filled;
12	2) The appropriation expended to support the Assess-
13	ment and Adjudication Division of the Juvenile Court should not exceed \$722,387 and should not be
14	supplemented from any other sources, including CETA;
15	3) The appropriation to the Social Development element should not exceed \$63,426 and should not be supple-
16	mented from any other sources, including CETA.
