

ORDINANCE NO. 2391

AN ORDINANCE relating to the King County Capital Budget and Program appropriating \$35,000 from the 1975 Park Emergency Contingency Project Account to the 1975 Park Acquisition and Development Fund for the Tolt River Park Facility and the Multipurpose Facility, and revising the 1975 Park Capital Improvement Budget; amending Ordinance No. 2230, Section 69, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation in the amount of \$35,000 to be transferred from the 1975 Park Emergency Contingency Project Account to the Park Acquisition and Development Fund for the Tolt River Park Facility Project No. 030071 (\$15,000), and the Multipurpose Facility Project No. 007061 (\$20,000).

SECTION 2. Ordinance No. 2230, Section 69, Attachment No. 1, as amended, is hereby revised as depicted on the attached Capital Budget information sheets.
