AN ORDINANCE making an additional appropriation of \$139,840 to the Building Modernization and Construction Fund from previously unallocated Tuberculosis Hospitalization Fund balance for the upgrading of facilities at Firland Detoxification Center and Cedar Hills Alcoholism Treatment Center as required by the State Fire Marshal, amending Ordinance No. 2230, Sections 57 and 69, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An additional appropriation to the Building Modernization and Construction Fund in the amount of \$139,840 to augment Project No. 002043, Phase I, Detox, from previously unallocated Tuberculosis Hospitalization Fund balance is hereby approved and adopted.

SECTION 2. Ordinance No. 2230, Section 57, as amended, is hereby amended to read as follows:




