Township 23, Range 6; east of the west boundary of Section 8, Township 23, Range 6; south of the centerline of Coalfield-Issaquah Road; west of the centerline of 212th Ave SE and its extension; north of the centerline of SE 160th St and its extension; east of the centerline of 204th Ave SE and its extension; north of the centerline of SE 140th St and its extension; shall hereafter be and constitute MAPLE HILLS Precinct.

That STAR LAKE Precinct shall be altered in the following manner: That area lying south of the centerline of S 268th St; west of the centerline of 42nd Ave S; north of the centerline of S 280th St; east of the centerline of Interstate Highway No. 5; south of the centerline of S 272nd St; east of the centerline of 40th Ave S; north of the centerline of S 270th St; and east of the centerline of 37th Ave S; shall hereafter be and constitute STAR LAKE Precinct.

That VALENCIA Precinct shall be altered in the following manner: That area lying east of the centerline of 164th Ave SE; south of the

centerline of SE 136th St; west of the centerline of 168th Ave SE; south of the centerline of SE 144th St; east of the centerline of 172nd Ave SE; west of the centerline of 176th Ave SE; west of the centerline of 177th Ave SE; south of the centerline of SE 143rd St; west of the centerline of 178th Ave SE; south of the centerline of SE 146th St; east of the centerline of 180th Ave SE; south of the centerline of SE 147th St; east of the northsouth line of the north-west quarter of Section 19, Township 23, Range 6; south of the centerline of SE 144th St; west of the centerline of 196th Ave SE and its extension; north of the extension of SE 148th St and north of a line running 200' north of Jones Road; shall hereafter be and constitute VALENCIA Precinct.
