ORDINANCE NO.

2431

AN ORDINANCE relating to the annexation of an area known as Annexation No. 27-A to Northeast Lake Washington Sewer District.

WHEREAS, Northeast Lake Washington Sewer District had found the petition for annexation of an area known as Annexation No. 27-A to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan, the basinwide sewer plan, and the county plan for sewer facilities;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Norhteast Lake Washington Sewer District of the area known as Annexation No. 27-A and described in Section 2 herein is approved.

SECTION 2. The area known as Annexation No. 27-A to be annexed is described as follows:

Beginning at the intersection of the centerline of Juanita Drive N.E. with the north right of way line of N.E. 122nd Place extended westerly in Section 25, Township 26 N., Range 4 E., W.M., situated in King County, Washington;

Thence northeasterly in and along said north right of way line of N.E. 122nd Place and N.E. 123rd Street to its intersection with the east line of said Section 25;

Thence southerly in and along said east line of Section 25 to its intersection with the north line of the southeast ½ of the southeast ½ of said Section 25;

Thence westerly along said north line of the southeast 1/4 of the southeast 1/4 to the northwest corner thereof which is also the southeast corner of the northwest 1/4 of the southeast 1/4 said Section 25;

Thence northerly along the east line of said northwest 4 of the southeast 4 to its intersection with a line 300 feet north of and parallel to the south line of said northwest 4 of the southeast 4;
