ORDINANCE NO.

SECTION 1. There is hereby approved and adopted the creation of a project, Milwaukee Road, Snoqualmie to Monroe, Project Number 007242.

SECTION 2. The King County Executive is hereby authorized to execute such contracts as are required with the present owner of the proposed Milwaukee Road, Snoqualmie to Monroe trail site, to secure an option to purchase same.
